**የወወህ speaks through his Nabay Menelik IV:**

Selamun is free to go. Because you, Cephas, have chosen not to obey me (የወወህ), nor my commands by not honoring your kinsmen whom I sent to you, your kinsmen who acted honorably and supported you in righteousness and love;

WHEREAS this day, I, የወወህ, have released them from your reproach. You Cephas, are no longer my appointed King of the BaSena, BaLemba diqique of Ezra'El. Because of your unrepentant heart, you have arrogantly ignored my laws, statutes, and the judgements I decreed, and have not humbled yourself before me; and

WHEREAS you Cephas, continue to ignore your sins against me, your Amlaki, and deny your transgressions against my true King Menelik IV, and his beautiful Queen whose hearts you know have no malice towards you. My King Menelik IV and his compassionate Queen, who humbled themselves and served you; your kinsmen as I commanded, and prayed for you and fasted and petitioned my Supreme Royal courts for my protection upon you; my servants who obediently agreed to leave all to follow my commands to support you as your kinsmen so that I may be esteemed.

Both the King and Queen served you diligently and instructed you in my counsel so that you would align with my will. Yet, you Cephas, acted deceitfully in your heart towards my servants, and you have spoken treasonous against my King and his kingdom. But you have not repented, nor have you attempted to amend your breach against him or his Queen. Why do you remain hardened in your heart towards your brother who treated you with love and kindness, why Cephas? What excuse shall you give to yourself? You are not a victim. Make amends for your unrighteousness and serve my King and his Queen whom I have appointed over you this day.

Present the restitution owed to your King. Do not remain rebellious in your heart towards my anointed. Repent Cephas, and offer the sacrifice which I instructed you to do. You may cancel your flight and be content where you are now. I, የወወህ, your Herzega, have released you and you are free to go. Layekun
