Re: Renouncement of the BaSena King

NOW THEREFORE, by the power of the Great Herzega YAW'WAH, I, Azzami Azaziaah as Seigneur Kahan of UPKY Kingdom, hereby renounce all affiliations with the BaSena Kingdom of Chili and or South Africa, known as BaSena Beta Ezra'El, whose King publicly projects using the name Benyamin Selamun, but privately retains usage of his legal birth name, Cephaz Mphafudi; and
