Re: Selamun's Transgressions Against UPKY

This decree is being issued to King Binyam Selamun of the BaSena Kingdom.

It has been decreed by **Poot** that King Binyam Selamun has acted against his brethren, kinsmen and Chashah Kingdom in an unrighteousness manner with an unrepentant heart, and has falsely accused Sobrahnah Menelik IV, and presented false witness against him to the BaSena Royal Courts.

Let it be decreed, today, that Sobrahnah Menelik IV acted in good faith, with King Binyam Selamun and the BaSena Kingdom, by supporting plans to gather the Bet Ezra'EL people. Sobrahnah Menelik IV acted in goodwill towards King Selamun through creating content, prayers, fasting, and issuing Ethereal messages of **Popt** to uplift, protect and support the BaSena Kingdom, and yet despite efforts of the Chashah Sobrahnah, he has been treated with disrespect and disdain by his kinsmen, King Binyam Selamun.

"The Treason against the Chashah Sobrahnah has been recognized in my Ethereal Courts." says, the Herzega የወወህ.

የውወህ speaks: King Binyam Selamun, you are accountable to me, Herzega የውወህ/ El Amalaki, of all spirit and all flesh. You have defied my instructions and the help that I sent you through my Sobrahnah Menelik IV. I, የውወህ, now decree that until you repent for the following transgressions, that your plans shall not succeed and you shall encounter death and destruction in all your plans.

For transgressions of King Binyam Selamun against የውውህ, repent this day for <u>not</u> returning to take your throne for seventeen years, for causing my people to suffer, for causing them to fall away from me because of your defiance, and not following my Ethereal Protocol.

Repent this day, for deceiving your kinsmen after he was obedient in delivering my messages and <u>admonishing your request to fast and petition my throne</u> for when your return time should be to South Africa.

I, Herzega የውወህ, deemed this time to be <u>October 2024</u>, which you defiantly rejected out of fear, disobedience and doubt.

For this treason and transgression against me, I Herzega Poot decree that your Kingdom shall not be established with my full authority unless you officially acknowledge, by royal order, your iniquity against me, and your tresspasses against your kinsmen Sobrahnah Menelik IV.

## **Sacrifice Instructions**

I, Herzega የውወህ, mandate that you <u>MUST make a slaughter sacrifice of atonement for all of your offenses</u>.

## **Royal Registry Records**

It has been recorded into the royal registry of the Chashah Kingdom through audio transcription regarding the following offenses committed against the Chashah Kingdom, His Majesty, the Sobrahnah Menelik IV, and Her Majesty, MRC the Sobrahnahga.

## Recorded dates and times of transgressions against the Chashah Kingdom are as follows:

- King Binyam Selamun did not show for the mutually agreed upon alliance meeting with Chashah Kingdom on: **SATURDAY, OCTOBER 12, 2024**
- King Binyam Selamun was more than 30 minutes late for meetings with Chashah Kingdom on: FRIDAY, SEPTEMBER 13TH, 2024 SATURDAY, OCTOBER 5TH, 2024 SATURDAY, OCTOBER 12, 2024
- King Binyam Selamun petitioned for prayers and advice on his behalf from Chashah Kingdom on: FRIDAY, AUGUST 30TH, 2024

Security detail matters regarding Admore and implementing new security training plans via Sobrahnah of the Chashah Kingdom to ensure safety for the BaSena King. The response that PDD delivered by Nabay Menelik IV on **September 3rd, 2024** instructing King Binyam to discontinue Ardmore's contract was disregarded by King Binyam Selamun and the BaSena Royal Council, and no resolution has been reported, and no training measures put in place as spoken by King Selamun.

• King Binyam Selamun petitioned for prayers and advice on his behalf from the Chashah Kingdom regarding:

When King Selamun's departure time from Chile should transpire. **Pool** spoke his instructions through Royal Bulletin, presented that the departure should be scheduled immediately and commence in October 2024. King Selamun confirmed the message was from Herzega **Pool**, and agreed to the date and timeline of **Pool** speaking to leave October 2024, as mandated on:

TUESDAY, SEPTEMBER 3RD, 2024 SUNDAY, SEPTEMBER 8TH, 2024

የውወህ spoke of King Selamun's deception towards his kinsmen of the Chashah Kingdom regarding his departure which was intentionally scheduled for December disobeying the mandate of የውወህ he vowed to keep, this deceiving his brethren.

- King Binyam Selamun verbally agreed to submit articles to the Chashah Kingdom for publication in a scholarly manner and cite references on: **SATURDAY**, **SEPTEMBER 28TH**, **2024**
- King Binyam Selamun sent a hostile message falsely accusing the Chashah Kingdom on: **SATURDAY OCTOBER 12, 2024**

የውወህ spoke of King Selamun's offense towards his kinsmen regarding bearing false witness against Sobrahnah Menelik IV before the BaSena Royal Council, and has mandated repentance and sacrificial atonement be made.

The Chashah Kingdom and it's Sobrahnah acted in good faith, kindness and compassion in all manner of respect with the BaSena Kingdom and His Majesty, King Binyam Selamun, but the Chashah Kingdom Royals were treated as personal servants by King Binyam Selamun on several occasions without regard of mutual Kingdom alliance, respect or appreciation, as King Binyam Selamun desired the Chashah Kingdom to perform all work related activities on social media accounts, articles, news and EDA activities, without the insertion of King Selamun's participation.

Unlawful and unrighteous acts of disrespect towards the Chashah Kingdom Royals led to an additional decree from የውወህ as follows:

## **Decree of Restitution**

I, the Herzega የውውህ, decree that restitution be made by King Binyam Selamun of the BaSena Kingdom to the Chashah Kingdom, and their Sobrahnah, in the sum of \$40,000 USD for the services rendered and treasonous acts inflicted upon the Chashah Kingdom.

I የውውህ, decree that until you <u>FOLLOW MY INSTRUCTIONS</u>, <u>repent for your transgressions</u>, <u>YOUR PLANS SHALL NOT SUCCEED</u>, and you shall encounter death and destruction in all your plans.
